Bidding is open to all eligible as per Section V of bidding document.

- Bidder must submit their bid electronically, Bidders are required to submit two separate bid response documents, one containing (i) the Technical Bid and the other (ii) the Price Bid, as per the provision of ITB 21 of the Bidding Document.

- Bidders who choose to submit their bid electronically may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp at no cost.
- Pre-bid meeting shall be held at **Ramgram Municipality office, Parasi, Nawalparasi** on 13:00 hrs, 2026/08/31.
- Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 hrs** on 2026/09/09. Bids received after this deadline will be rejected.
- The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hrs on 2026/09/09 at the office of **Ramgram Municipality**. Bids must be valid for a period of 90

days from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs 6,50,000.00 (Six lakhs and fifty thousands only), which shall be valid for 30 days beyond the validity period of the bid (i.e. 2027/01/07).

9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
